- Recognition so granted shall be reviewed after every 10 years. 9.

No financial assistance shall be granted by the Department to the school. 10.

School premises shall not be used for commercial purpose and sixti National activities.

Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the 11. 12.

The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./ Department as required 13.

In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action 14. in case of violation of any provisions of the rules.
